Executive Summary

The Compliance Verification Framework establishes systematic procedures for verifying operational compliance with IOOPS protocols across all member jurisdictions. This framework ensures consistent, objective assessment of operational entities while maintaining flexibility for jurisdiction-specific requirements.

1. Verification Methodology

IOOPS employs a multi-tiered verification approach combining: (1) Self-assessment and reporting, (2) Document review and analysis, (3) On-site inspection and audit, (4) Continuous monitoring and surveillance, (5) Periodic re-certification procedures.
